Write balanced chemical equations for the following reactions.

*Hydrogen gas (collected in air) is also collected in (about) 1.5 times that amount (g) as in 1.*

1. Acetylene ( $\text{C}_2\text{H}_2$ ) reacts with oxygen (hydrogen + fluorine for three acetylenes, a fluorine)  

$$3\text{C}_2\text{H}_2 + 5\text{F}_2 \rightarrow 6\text{HF} + 3\text{C}_2\text{F}_4$$

2. Calcium carbonate is decomposed (superheating) to form calcium oxide and carbon dioxide.  

$$\text{CaCO}_3 \rightarrow \text{CaO} + \text{CO}_2$$

3. Barium sulfate reacts with water for three barium hydroxides  

$$\text{BaSO}_4 + 3\text{H}_2\text{O} \rightarrow 3\text{Ba}(\text{OH})_2$$

4. Methanethiol ( $\text{CH}_3\text{SCH}_3$ ) decomposes to form methane ( $\text{CH}_4$ ) and carbon monoxide.  

$$\text{CH}_3\text{SCH}_3 \rightarrow \text{CH}_4 + \text{CS}_2$$

5. Zinc reacts with oxygen ( $\text{O}_2$ ) to form zinc oxide (zinc + oxygen)  

$$2\text{Zn} + \text{O}_2 \rightarrow 2\text{ZnO}$$

6. Calcium sulfate decomposes (superheating) to form calcium oxide and sulfur dioxide.  

$$\text{CaSO}_4 \rightarrow \text{CaO} + \text{SO}_2$$

7. Iron reacts with sulfur gas ( $\text{S}_2$ ) to form iron (II) sulfide and hydrogen gas.  

$$\text{Fe} + \text{S}_2 \rightarrow \text{FeS}_2 + \text{H}_2$$

8. A nitrogen-containing carbon compound,  $\text{C}_2\text{H}_5\text{N}_3$ , decomposes to form ethane,  $\text{C}_2\text{H}_6$ , and nitrogen gas.  

$$\text{C}_2\text{H}_5\text{N}_3 \rightarrow \text{C}_2\text{H}_6 + \text{N}_2$$

9. Phosphorus,  $\text{P}_4\text{O}_{10}$ , is formed when carbon monoxide reacts with phosphorus gas.  

$$\text{P}_4 + 10\text{CO} \rightarrow \text{P}_4\text{O}_{10} + 10\text{C}$$
