#### Meaning of Concurrent Audit:

The term Concurrent means "operating or occurring at the same time". Concurrent audit means verifying the financial transaction at the same time or after the transaction has occurred by bank on a regular basis to ensure the authenticity and accuracy of the transactions on true and fair basis as per the guidelines suggested by the Reserve Bank of India. The emphasis under concurrent audit is not on test checking but on substantial checking of transactions

# LOANS and ADVANCES Area:

The most important section for auditors point of view is Loans and Advances where the major risk is held. The loans are classified into two categories:

#### A. Fund Based:

- In simple terms fund based loans means where the fund are transferred to applicant for the purpose of loan.
- ✓ Fund based Loans are like Cash credit, Overdraft, Home loan, vehicle loan, Gold Loan etc.

#### B. Non Fund based:

- In this type the bank does not give physical money to the applicant but gives an assurance to the third party.
- ✓ Non Fund Based loans are Letter of credit, Bank Guarantee Etc.

#### - Home loan:

This is a facility provided to the borrower for Purchase of New/Old house or Flat and also for construction/Renovation for a certain period of time and loan is repaid on fixed installment basis.
