#### THE ROLES OF MANAGEMENT ACCOUNTING

- Accounting is "the process of identifying, measuring and communicating economic information to permit informed judgements and decisions by users of the information"
- Financial accounting is concerned with the provision of information to parties outside the organisation
- Management accounting is concerned with the provision of information to people within the organisation
- Managers need accounting information "to help them make better decisions and improve the efficiency and effectiveness of existing operations"

#### ACCOUNTING AND DECISION-MAKING.

- Historically, the Management Accountant produced information for
  - Inventory valuation and external profit reporting
  - Helping managers make better decisions
  - Helping planning and control, performance measurement and continuous improvement
- Performance measurement is not limited to accounting
  - Customer satisfaction
  - Quality (TQM)
  - Time-based measures of efficiency and effectiveness such as 'cycle time'
  - Innovation and continuous improvement
