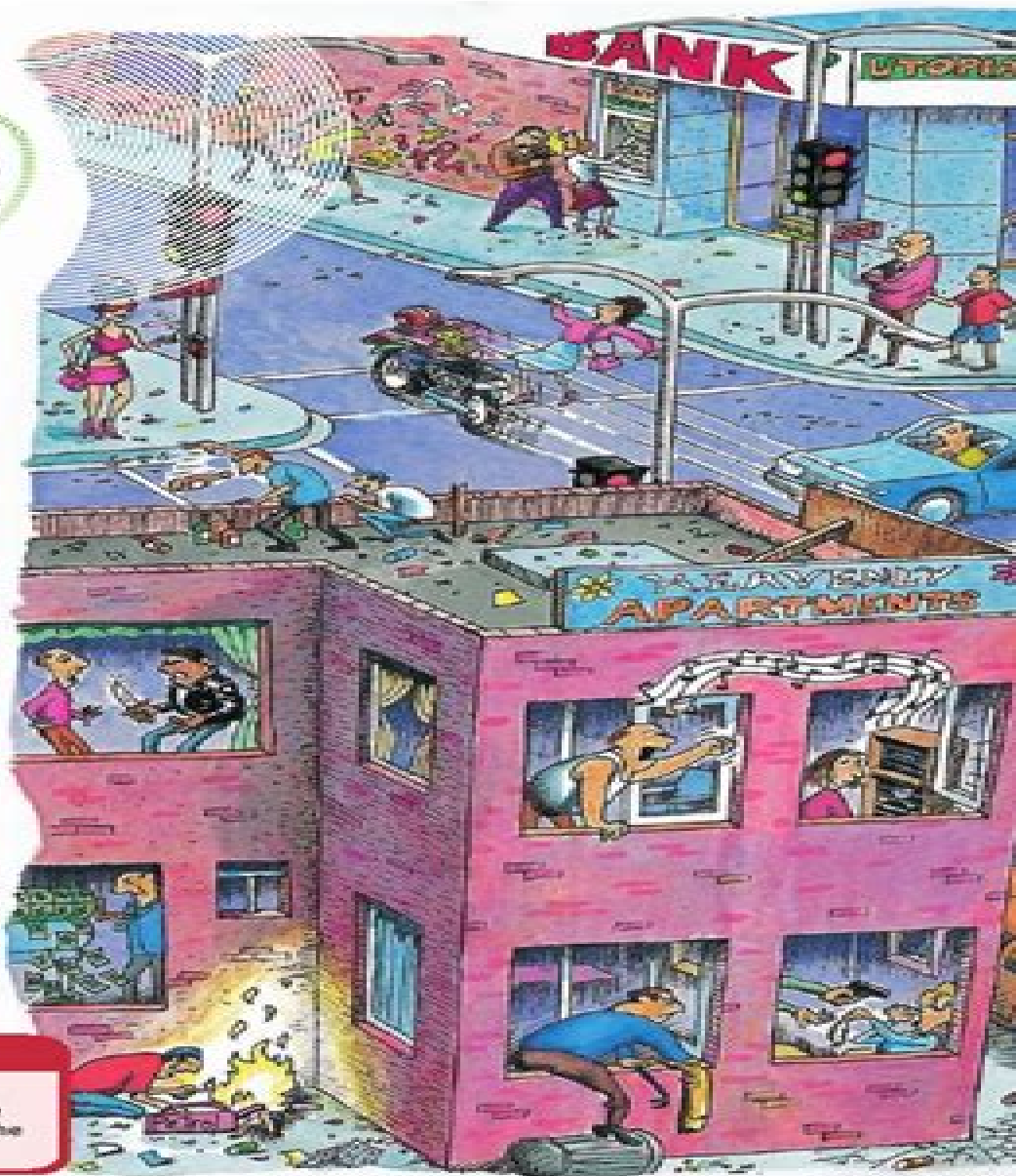
The law in action
