- b) If she makes the greatest number of arrangements, how many daisies and how many roses will be in each arrangement?

$$4 \times 7 = 28 \text{ daisies}$$

$$4 \times 8 = 32 \text{ roses}$$

7 daisies and 8 roses in each arrangement

8. A cookie recipe calls for $\frac{3}{4}$ cup of sugar. If you have 3 cups of sugar in your pantry, how many batches of cookies can you make? (note: you want to make as many as possible, so use all of the sugar.)

I can make 4 batches of cookies.

$$3 \div \frac{3}{4} = \frac{3}{1} \times \frac{4}{3} = \frac{12}{3} = 4$$

9. Jeri has a recipe that uses $2\frac{1}{2}$ cups of flour. She only has a $\frac{1}{4}$ -cup measure.

How many scoops of flour does Jeri need to use?

She needs to use 10 scoops of flour.

$$2\frac{1}{2} \div \frac{1}{4} = \frac{5}{2} \div \frac{1}{4} = \frac{5}{2} \times \frac{4}{1} = \frac{20}{2} = 10$$

10. Matilda bought a block of cheddar cheese. The block weighed $3\frac{3}{5}$ pounds. She cut the block up into three equal pieces. What was the weight of each piece of cheese?

$$3\frac{3}{5} \div 3 = 1\frac{1}{5}$$

$$\text{Proof: } 1\frac{1}{5} \times 3 = \frac{6}{5} = 1\frac{1}{5}$$

Each piece weighs 1 1/5 pounds.

11. You have 3 cups of fruit punch concentrate. If you mix $2/5$ cup of the concentrate with 1 gallon of water, you can make a pitcher of lemonade.

- a. How many pitchers of lemonade can you make with the 3 cups of concentrate?

$$3 \div \frac{2}{5} =$$

- b. How much water will you need if you use all of the concentrate?

You will need 7 1/2 gallons of water.

$$3 \times \frac{5}{2} = \frac{15}{2} = 7\frac{1}{2}$$
