Managerial Accounting: a field of accounting that provides economic and financial information for managers and other stakeholders

Differences Between Financial and Managerial Accounting

Features	Financial Accounting	Managerial Accounting

Management Functions and Organizational Structures

Board of Directors: the group of officials elected by the shareholders and management to run the organization or business organization; highest authority; ultimate decision maker for company

Chief Executive Officer (CEO): the corporate officer who has overall responsibility for managing the business; he or she delegates work of other departments; he/she is corporate officer

Chief Financial Officer (CFO): the corporate officer who is responsible for all company's accounting and financial issues

Chief Operating Officer (COO): the corporate officer who is responsible for all company's

operating and financial issues

Controller: the financial officer who is responsible for a company's accounting records, system of internal controls, and preparation of financial statements, tax returns, and internal reports
