

MICHIGAN SALES TAX EXEMPTION CERTIFICATE (FORM 3372)

****For internal Indiana University use only****

Note: According to Mich. Admin. Code R205.74, Indiana University is exempt from sales and use tax as an educational institution. The University must issue the attached certificate to sellers when purchasing tangible personal property or taxable services to qualify for exemption from MI sales and use taxes. A seller may accept Form 3372 from Indiana University at the time of sale, or within 120 days after the sale to establish the privilege of the exemption.

- Purchases must be paid for with University funds in the following manner:
 - Are directly invoiced and charged to Indiana University, and
 - Are directly paid by Indiana University via
 - check,
 - credit card
- The exemption applies to sales, not for resale, to regularly organized educational institutions not operated for profit.
- It is not necessary to give the seller a new certificate every time you make a purchase. A blanket exemption claim covers all exempt transfers between the University and the seller for a four year period as long as there is a recurring business relationship between University and seller. A recurring relationship exists when not more than 12 months passes between sales transactions.
