One can enter and exit these sessions as per their own will and in any case, will not be forced to agree to any terms.

And as we know that the matter of the dispute can be quite sensitive in nature, this process is extremely confidential. Whatever happens in this session shall stay within the four walls of this room.

After we conclude with our introductory remarks, each one of you can take the floor to discuss what led you to seek mediation today, based on which we will form certain agendas. Agendas are basically a list of issues that both the parties wish to address in this session and they also serve as a roadmap for the discussion.

In case the parties get into a halt where the conversation is not moving forward, the parties may call for a private session which in mediation is known as the caucus session. During the caucus, we will talk to each party individually. Anything disclosed in the caucus will be extremely confidential and will not be disclosed to the other unless the parties in the caucus allows us to do so.
