That pursuant to Republic Act No. 11576, July 30, 2021, otherwise known as, AN ACT FURTHER EXPANDING THE JURISDICTION OF THE METROPOLITAN TRIAL COURTS, MUNICIPAL TRIAL COURTS IN CITIES, MUNICIPAL TRIAL COURTS, AND MUNICIPAL CIRCUIT TRIAL COURTS, AMENDING FOR THE PURPOSE BATAS PAMBANSA BLG. 129, OTHERWISE KNOWN AS "THE JUDICIARY REORGANIZATION ACT OF 1980", AS AMENDED states as follows:

Section 1. Section 19 of Batas Pambansa Blg. 129, otherwise known as " The Judiciary Reorganization Act of 1980," as amended, is hereby amended to read as follows:

"Section 19. Jurisdiction of the Regional Trial Court shall exercise exclusive original jurisdiction:

XXXXXXXXXXXX

" (8) In all other cases in which the demand, exclusive of interest, damages of whatever kind, attorney's fees, litigation expenses and costs or the value of property in controversy exceeds two million pesos (P 2,000,000.00).

Section 2. Section 33 of the same law is hereby amended to read as follows:

" Section 33. Jurisdiction of the Metropolitan Trial Courts, Municipal Trial Courts in Cities, Municipal Trial Courts, and Municipal Circuit Trial Courts shall exercise:
