IMPORTANT: Read the instructions before completing your application. Incomplete or incorrect applications will be returned. The entity performing the billing must complete this form.

The purpose of the EDI Customer Profile is to enroll suppliers, billing services, clearinghouses and software vendors as electronic submitters and recipients of electronic claim data. The entity (supplier, billing service, clearinghouse, or software vendor) that will be billing directly to Jurisdiction D must complete the EDI Customer Profile.

In order to enroll a supplier that is not already setup with Jurisdiction D for electronic billing, all three (3) pages of the Customer Profile must be sent with all three (3) pages of the Jurisdiction D EDI Enrollment Form. You may access the Jurisdiction D EDI Enrollment Form at: <http://www.dmeconnectmentservices.com/edi/dmeco/forms.htm>. Existing EDI billers may change or add information to their submitter profile by using the Jurisdiction D EDI Customer Profile only.

Incomplete or incorrect applications will be returned. In order to complete the EDI application, both the supplier number and NPI number are required. All complete applications are processed within 21 business days from the date the application is received. Applications with 100 or more supplier numbers will require an additional 10 business days for processing. A letter containing the Submitter ID, EDI ID with initial password, and software (if applicable) will be mailed upon completion of the application.

The EDI ID and password act as an electronic signature, therefore the submitter would be liable if any entity performed an illegal action while using that EDI ID and password. Likewise, an EDI ID and password is not transferable, meaning that it may not be given to a new owner of the submitter's operation. New owners must obtain their own EDI ID and password.

New EDI Submitter Tips

Complete Section 1, 2, 3, 4 and 9. If applicable, complete sections 5, 6, 7 and 8.

If you want to transmit claims directly to **another** DME MAC and have them automatically **transfer** to Jurisdiction D, you must complete sections 1, 2, 3, and 8. Only indicate the Formset in Section 4. If applicable, complete sections 5, 6, 7 and 8.

Change:

- Customer information, complete sections 1, 2 and 9.
- Claim transmission information, complete sections 1, 2, 4 and 9.
- Software vendor information, complete sections 1, 2, 4, 5 and 9.

- Supplier number, complete sections 1, 2, 3 and 9.
- Additional Features (ENR, Beneficiary Eligibility and CSI), complete sections 1, 2, 3, 6 and 9. If applicable, complete sections 7 and 8.
