Além disso, esta obra traz considerações a respeito dos riscos tangíveis aos investimentos em startups e seus principais meios de mitigação, apresentando instrumentos capazes de potencializar investimentos em Startups no Brasil, tendo como principal diferencial a blindagem dos investidores no setor representado pelo Contrato de Participação por meio da Lei Complementar nº 155/2016. Este livro inicia com o conceito de empreendedor e empreendimento, tratando em especial do empreendedorismo no Brasil. Aborda também os aspectos legais que fazem parte de um empreendimento, além de sua relação com o tipo de sociedade escolhida para dar início ao negócio. No decorrer do texto, o leitor encontrará imprescindíveis considerações sobre startups, seu conceito e os diversos tipos e fases de investimentos, cabíveis além de suas características e ferramentas de proteção, possibilitando que o empreendedor e o investidor criem um negócio seguro com base em ferramentas legais adequadas. Do mesmo modo são apresentadas nomenclaturas e definições acerca de investimentos, contratos societários, riscos e mitigação de riscos relacionados ao empreendedor e startup, para que o empreendedor leigo se familiarize com as diversas abordagens que o negócio traz. No âmbito legal, a presente obra disserta sobre a criação da sociedade empresarial e da consequente personificação societária, entendendo os limites da responsabilidade patrimonial dos sócios, garantida pela autonomia patrimonial. Especificamente no que diz respeito às inovações legais relacionadas às startups, será abordada a figura do investidor anjo e será apresentado o Contrato de Participação regulado pela recente Lei Complementar nº 155/2016. Essa novidade trazida pela legislação brasileira tem por finalidade fomentar os investimentos em startups, protegendo os empreendedores por meio da isenção de responsabilidade que tal lei proporciona. Por fim, este é um livro que trata dos principais aspectos legais e comerciais de uma startup, bem como da busca pela mitigação de riscos inerentes ao negócio empresarial, oferecendo uma leitura simples de maneira que o empreendedor independentemente de sua formação ou nível educacional possa se preparar e orientar-se para melhor desenvolver seus projetos.
