6) Connect the 14-pin cap on the ABTI-6M3 cable to the 14-pin plug connected to the vehicle (the connector that was removed from the back of the radio).



7) Connect the 16-pin cap on the ABTI-6M3 cable to the 16-pin plug connected to the vehicle (the connector that was removed from the back of the radio).



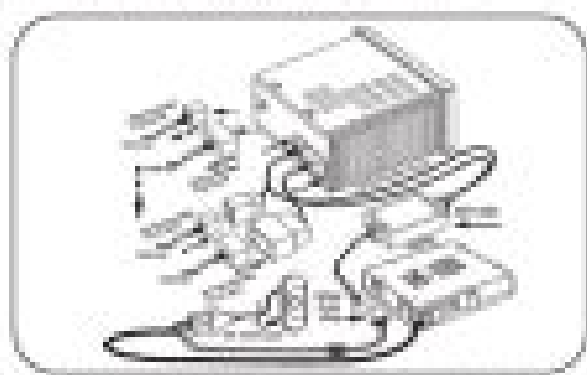
8) Connect the white 13-pin plug on the ABTI-6M3 cable to the ABTI-6M3 module.



9) Connect the white 8-pin plug on the HF-1000 cable to the ABTI-6M3 power cable, and connect the other end of the power cable to the ABTI-6M3 module.

10) Route the HF-1000 keypad to the dashboard of the vehicle (refer to HF-1000 instructions), and route the wire to the HF-1000 harness. Attach the keypad connector to the harness.



11) Install the HF-1000 microphone in an appropriate location (see HF-1000 instructions), route the wire to the HF-1000 harness, and attach the microphone connector to the harness.

12) Secure all components, and reinstall the radio.

13) Reconnect the vehicle battery.

OPERATION

Refer to the HF-1000 manual for operation. All audio signals from the HF-1000 will be played through the car stereo. Adjust the volume using the radio's volume knob to a comfortable level. Audio from FM, CD, Satellite etc. will be automatically paused or muted while calls are in process. Any buffer operations will prompt the operation of the HF-1000. Keep in mind that if buffer operations start while you are on a call, the call will continue and the radio will be able to hear you - watch what you say!

The vehicle's radio does not need to be on for HF-1000 operations, but the vehicle's ignition must be on or in accessory mode.
